#### **Arrangements**

- Anyone who turns up for an assessment who has not received confirmation from the SJIB will be turned away.
- The assessment will start promptly at the scheduled time and end approximately 40 minutes later. Please allow plenty time to be seated prior to the start of the assessment.
- Please bring photographic proof of identity e.g. Passport, Driving Licence, SJIB Grade (ECS) Card. Failure to provide this will result in the assessment being rescheduled.
- You will not be admitted to the assessment after it has started.
- You must switch off all communication devices such as mobile phones and pagers before entering the assessment room.
- If, in the opinion of the Invigilator, you act in a manner likely to disrupt the Health and Safety Assessment, you will be disqualified and asked to leave the assessment room.
- During the Health and Safety Assessment, you will not be permitted to communicate with other candidates under any circumstances.
- If you finish the assessment before others, you are expected to remain quiet until all candidates have completed the assessment.
- There is a Customer Satisfaction Survey which we would appreciate if you could complete at the end of assessment, this is optional, however if the assessment goes to full time, there will be time added to complete survey.
- If you have learning difficulties, or are unfamiliar or uncomfortable dealing with the assessment, please bring this to the attention of the ECS Administrator when you are booking the assessments and they will make alternative arrangements in a sympathetic and confidential manner.
- When possible the results will be processed and posted to Candidates (first class) by Monday.
